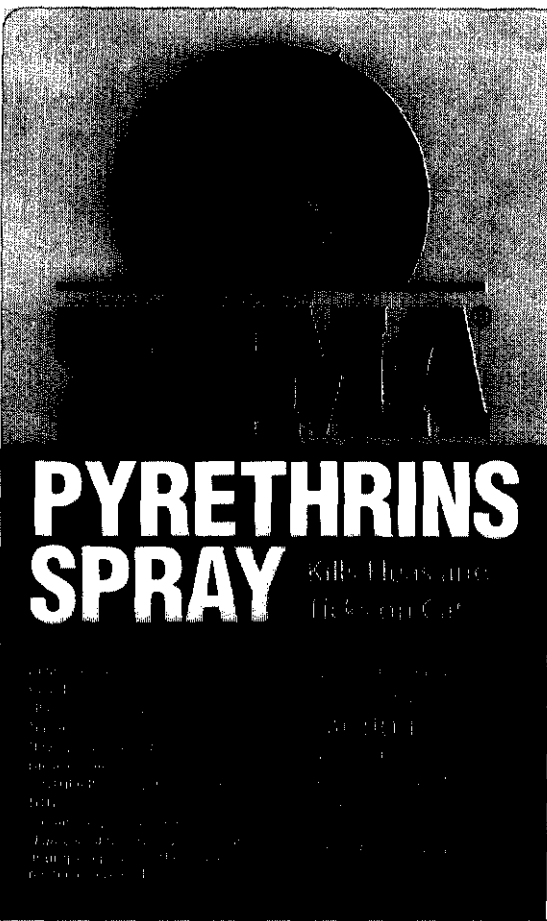

As you spray, fluff the hair so the spray will penetrate to the skin. Make sure spray wets ticks thoroughly. Do not spray into the eyes, face or genitals. Do not reapply product for 3 days.
