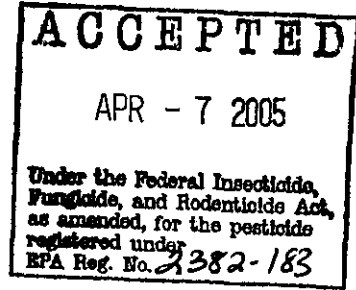

HAZARD TO HUMANS: Harmful if swallowed or absorbed through the skin. Avoid breathing spray mist or vapor. Avoid contact with eyes, skin or clothing. FIRST AID

=====

- If Swallowed**
- Call a poison control center or doctor immediately for treatment advice.
 - Have person sip a glass of water if able to swallow.
 - Do not induce vomiting unless told to do so by a poison control center or doctor.
 - Do not give anything by mouth to an unconscious person.

- If On Skin or Clothing**
- Take off contaminated clothing.
 - Rinse skin immediately with plenty of water for 15-20 minutes.
 - Call a poison control center or doctor for treatment advice.

- If In Eyes**
- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
 - Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes.
 - Call a poison control center or doctor for treatment advice.

- If Inhaled**
- Move person to fresh air.
 - If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.
 - Call a poison control center or doctor for further treatment advice.

ZEMA IGR Premise Spray kills fleas and ticks. This product contains a unique combination of ingredients that kills both adult and pre-adult fleas, and even kills fleas before they grow up to bite. NYLAR®, a unique ingredient in the flea spray, continues to kill fleas for 120 days (4 months) by preventing their development into the adult biting stage. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, and floor cracks. Protects your home from reinfestation and buildup. Protects your pets and family from bites. One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectionable or sticky mess and when used as directed, does not stain furnishings.

FLEAS & TICKS: SHAKE WELL BEFORE EACH USE: Hold can 2 or 3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture. Be sure to treat pet bedding as this is a primary hiding place for fleas. No need to remove pet bedding after treatment.

DO NOT TREAT PETS: Use a registered flea control product on your pets in conjunction with this treatment. Repeat as necessary. Avoid wetting furniture and carpeting. A fine mist of spray applied uniformly is all that is necessary to kill fleas and ticks.
