If, after formal consultation with the appropriate Service(s), additional modifications are identified for any chemical in this product in the Service's Biological Opinion(s) for that chemical, EPA will notify Virbac Ah, Inc. in writing consistent with the terms in that Biological Opinion of any necessary required changes.
