## **CAUTION**

#### KEEP OUT OF REACH OF CHILDREN, DOMESTIC ANIMALS AND PETS

Place baits in locations not accessible to children, pets, and domestic animals, or in tamper-proof bait boxes. If swallowed by humans, domestic animals or pets, this material may reduce the clotting ability of the blood and cause bleeding. In such case, intravenous and oral administration of Vitamin K, combined with blood transfusions are indicated as in the case of hemorrhage caused by overdoses of bishydroxycoumarin.

#### **INSTRUCTIONS**

Mix thoroughly 1 part Hopkins .5% Warfarin Concentrate with 19 parts (by weight) of a suitable bait material such as freshly ground whole yellow corn, rolled oats, or other dry grain materials attractive to rats and mice. If very dusty, add up to 5% of a bland edible oil such as mineral or corn oil. One pound makes 20 lbs. of mixed bait.

FOR CONTROLLING RATS: Place 4 to 6 ounces of mixed bait in container where rats are known to feed or run. Assure an uninterrupted supply of bait for a period of not less than 12 days and continue baiting until all signs of feeding have stopped. Never let a bait station remain empty - check daily. Replace stale, damp or moldy baits with fresh bait.

FOR CONTROLLING MICE: Place tablespoonful quantities of mixed bait in shallow containers where mice and signs of mice have been seen. Bait stations of intervals of 6 to 8 feet are recommended. Assure an uninterrupted supply of bait for a period of not less than 15 days, or until all signs of feeding have stopped.

Near dumps and other sources of continual infestation, use permanent bait stations and replenish as bait is consumed.
