DIRECTIONS FOR USE

CORN—To protect germinating seeds and seedlings against seed corn beetles and seed corn maggot, apply 3-4 ½ ounces 1970 Diazinon Seed Protectant per bushel of seed (1 heaping measure equals one ounce) at planting time, either by thoroughly mixing in a box or tub or by dusting it over the seed as it is dumped into the planter box. Thoroughly stir the product with a paddle or lath onto the seed so that each seed is coated with the seed protectant. If temperature is high and soil moisture is low, reduce dosage to one-half, especially for mid-season planting. **DO NOT USE BARE HANDS.**

1970 Diazinon Seed Protectant should be applied in conjunction with or over an approved fungicidal seed treatment, but do not use on seed already treated with an insecticide. Plant within one month of treatment.

Under some circumstances 1970 Diazinon Seed Protectant may affect the rate of seedling. It is necessary for the user to check planting rate frequently to assure himself that the desired planting rate is being obtained.
