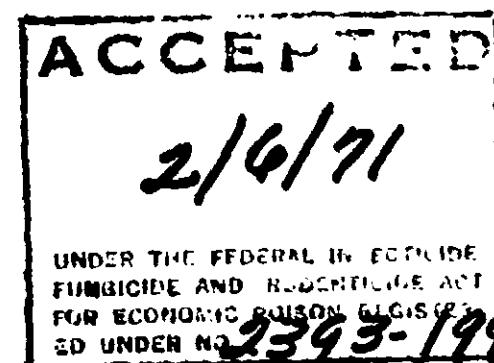


LEFT BACK PANEL



DIAZINON SEED PROTECTANT

To protect germinating corn seed and seedlings against seed corn beetles and seed corn maggot. This product contains graphite to assist in accurate planting.

DIRECTIONS FOR USE

CORN - To protect germinating seeds and seedlings against seed corn beetles and seed corn maggot, apply contents of this packet to 1 bushel seed at planting time by dusting it over the seed as it is dumped into the planter box. Thoroughly stir the product with a paddle or lath onto the seed so that each seed is coated with the seed protectant. If temperature is high and soil moisture is low, reduce dosage to one-half, especially for mid-season planting. DO NOT USE BARE HANDS.

PEAS, SOYBEANS AND BEANS (LIMA, SNAP, WHITE AND KIDNEY) SEED CORN MAGGOTS: Apply contents of this packet to 1 1/2 - 3 bushels of seed as a dry mixture in the planter box as a seed treatment prior to planting.

Diazinon Seed Protectant should be applied in conjunction with or over an approved fungicidal seed treatment, but do not use on seed already treated with an insecticide. Plant within one month of treatment.

Under some circumstances Diazinon Seed Protectant may affect the rate of seeding. It is necessary for the user to check planting rate frequently to assure himself that the desired planting rate is being obtained.
