





Retreatments may be necessary in 6 to 12 months depending on soil type rainfall following treatment, and weed species present Application equipment should be thoroughly cleaned

Application equipment should be uncoughly characteristic and water to prevent corrosion. Equipment which has been used to apply this product should not be used for applying insecticides, fungicides, fertilizers or other agricultural chemicals to desirable plants as plant equip or loss may result
