

**PRECAUTIONARY STATEMENTS  
HAZARD TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION:** Keep away from humans, domestic animals and pets. If swallowed, this material may reduce the clotting ability of the blood and cause bleeding.

**NOTE TO PHYSICIAN:** If ingested, administer Vitamin K<sub>1</sub> intramuscularly or orally, as indicated in bishydroxycoumarin overdose. Repeat as necessary based on monitoring of prothrombin times.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**DISPOSAL**

Do not reuse empty container.  
Wrap container and put in trash collection.

**USE RESTRICTIONS:** For control of Norway rats, Roof rats and House mice in and around homes, industrial and agricultural buildings, and similar man-made structures, and in transportation vehicles.

Treated baits must be placed in tamper-proof bait boxes or in locations not accessible to children, pets, domestic animals or wildlife. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

When used around feedlots, kennels and similar operations, bait must be in protected areas outside of pens.

**SELECTION OF TREATMENT AREAS** — Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Protect bait from rain or snow. Remove as much food as possible.

**RATS & MICE:** Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and unconsumed bait properly. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

**RATS:** Break and place 4 to 16 oz. of Rodex Blox-1 in areas where rats are accustomed to feed unobserved. Assure an uninterrupted supply of bait for a period of not less than 10 days and continue baiting until all signs of feeding have stopped.

**MICE:** Break Rodex Blox-1 into 1 oz. pieces and place at 4 to 10 ft. intervals where mice are active. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Assure an uninterrupted supply for a period of not less than 15 days.
