PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS & DOMESTIC ANIMALS

CAUTION: Keep away from humans, domestic animals and pets. Exposure during pregnancy should be avoided.

When mixing baits, wear dust respirator and rubber gloves.

If on Skin: Wash thoroughly with soap and water.

If Swallowed: Call a physician or Poison Control Center immediately. Induce vomiting by drinking 1 or 2 glasses of water and touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

If in Eyes: Flush with water.

NOTE TO PHYSICIAN: If swallowed by humans, domestic animals or pets, this material may reduce the clotting ability of the blood and cause bleeding. In such case, intramuscular and oral administration of Vitamin K1 combined with blood transfusions are indicated, as in the case of hemorrhage caused by overdoses of bishydoxycoumarin. Repeat as necessary based on monitoring of prothrombin time.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

MIXING DIRECTIONS

Mix 1 part this product with 19 parts (by weight) of a suitable bait material such as freshly ground whole yellow corn, rolled oats, or other dry grain materials attractive to rats and mice. If very dusty, add up to 5% of a bland edible oil such as mineral or corn oil. One pound makes 20 lbs of mixed bait.

As an example of ingredients to be used: mix thoroughly 1 part of this product with 17 parts whole coarse ground wheat and 2 parts of powdered sugar.

Bait materials resembling human food must be altered in form by, crushing, balling, or pelleting so that they are not readily reacognizable as food.

USE DIRECTIONS: For control of Norway rats, Roof rats and House mice in and around homes, industrial and agricultural buildings, and similar man-made structures, in transportation vehicles, or sites such as dumps, sewers, river and pond banks, feedlots, rabbitry fur farms, and game bird operations.

Treated baits must be placed in tamper-proof bait boxes or in locations not accessible to children, pets, domestic animals and wildlife. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

SELECTION OF TREATMENT AREAS. Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Protect bait from rain or snow. Remove as much food as possible.

APPLICATION DIRECTIONS

RATS: Apply 4 to 16 ounces of bait per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days.

MICE: Apply 1/4 to 1/2 ounce (1-2 level tablespoons) of bait at 8 to 12 foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

RATS & MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and unconsumed bait properly. To prevent reinfestation, eliminate food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

STORAGE AND DISPOSAL

12 pt.*(on front panel)

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE DISPOSAL: Pesticide that cannot be used according to label instructions must be disposed of according to Federal or approved state procedures under Subtitle C of the Resource Conservation and Recovery Act.

CONTAINER DISPOSAL: Completely empty bag by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of bags in a sanitary landfill by by incineration if allowed by State and local authorities.
