To kill lice and louse eggs: Spray in an inconspicuous area to test for possible staining or discoloration. Inspect again after drying, then proceed to spray entire area to be treated. Hold container upright with nozzle away from you. Depress valve and spray from a distance of 8 to 10 inches.

Spray each square foot for 5 seconds or until damp.

Spray only those garments, parts of bedding, including mattresses and furniture that cannot be either laundered or dry cleaned.

Treat entire lower surface of all clothing to be worn next to the skin. Special attention should be given to seams and areas around the neck, armpits, waist, shirttail and crotch of the pants.

Allow all sprayed articles to dry thoroughly before use.

Repeat treatment as necessary.
