

FOR THE CONTROL OF TERMITES: Prepare a 0.3% emulsion by adding 1 gallon of Master Spray 14 to 60 gallons of water and apply at the following rate:

1. Apply 2 gallons per 5 linear feet to critical areas under the house. Treatment should be made along the inside of Foundation walls, around piers, sewer pipes, conduits, etc.

2. Apply 1 gallon per linear feet in a narrow trench, no deeper than the top of the footings, along the outside of foundation walls. Replace the soil and apply another 1 gallon to 5 linear feet to the back tilt and cover the back fill with a layer of soil. If the trench is more than 15 inches in depth, double the rate of application. A trench 30 inches deep is the maximum depth required next to foundations.

3. Apply 1 gallon per 10 square feet of soil surface under attached porches, entrance platforms, utility entrances, concrete slabs on the ground, and under basement flooring.

All trenches along the outside of foundation walts must be filled and buildings with crawl spaces should be guarded to prevent children or animals entering the treated areas.

Mix Master Spray 14 with water by agitation; agitate the mixture while spraying. If allowed to stand, reagitate before use.
