DIRECTIONS

Master Brand M-22 Dust can be used for the control of many common diseases of vegetables and field crops. This dust may be applied to either moist or dry foliage any time dusting conditions are favorable. Applications should begin when plants are small. Use 25 to 50 pounds per acre depending on the size of plants. Repeat at 5 to 10 day intervals depending on the severity of disease conditions. Dusters should be adjusted to give uniform and thorough coverage.

- ① Tomatoes—Early and late blight, Anthracnose, grey leaf spot, septoria leaf spots; Begin dusting when disease is first reported in area and repeat application at 7 to 10 day intervals or oftener under severe late blight conditions.
- ② Potatoes—Early and late blight. Begin dusting when disease is first reported in the area and apply 7 to 10 day intervals or oftener under severe late blight conditions.
- Cucumbers, Cantaloupes, Melons, Squash, Watermelons—Anthracnose and Downy Mildew; Start applications when runners begin to form or at the first sign of disease. Repeat at weekly intervals. Direct dust to underside of leaves.
