DIRECTIONS

FOR THE CONTROL OF TERMITES: Prepare a 0.3% solution from Master Brand Termite Kill by adding one quart of concentrate to 10-15 gallons of water or one gallon of concentrate to 40-60 gallons of water and apply at the following rates:

SLAB-TYPE CONSTRUCTION: Apply one gallon of solution per 10 sq. ft. as an overall pre-construction treatment under the slab and under attached porches. Apply one gallon per 5 lineal feet to critical areas under the slabs as pre-construction treatment, such as along the inside of foundation walls and around utility entrances and interior partition foundation walls. Apply one gallon per 5 lineal feet along the outside of the foundation using a trench to the depth of the foundation.

CRAWL-SPACE HOUSES AND HOMES WITH BASEMENT: Apply one gallon per 5 lineal feet as a trenching application to critical areas under the house, such as along the inside of foundation walls and around piers and utility entrances. If trench is deeper than 15-18 inches, apply two gallons per 5 lineal feet. Apply one gallon per 5 lineal feet in a trench along the outside of foundation walls, including entrance platforms and porches where the foundation is not more than 15-18 inches deep. If over 15-18 inches deep, apply 2 gallons per 5 lineal feet of trench. For buildings with deep foundations, dig a trench 30 inches deep. Apply 4 gallons per 5 lineal feet. Apply one gallon per 10 square feet of soil surface as a pre-construction treatment where the attached porches, entrance platforms, utility entrances, etc., have covering slab on fill of ground.

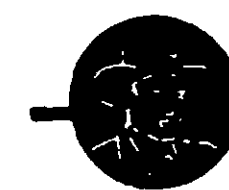
