DIRECTIONS

This product is designed for the control of common insects usually found in and around peanut shelling plants, elevators and where shelled peanuts are stored. Master Brand Mill Spray should be used for the control of the exposed stages of the (Indian Meal Moth, Confused Flour Beetle, Saw-toothed Grain Beetle, Granary Weevils, Flies, and Roaches) attacking peanuts.

Close all doors and windows and fill the space being treated with a cloud of fine mist, spraying freely towards the ceiling in all directions. Walls, bins and storage areas should be thoroughly cleaned and sprayed with a direct heavy mist. Observe sanitary measures that reduce insect breeding.

Do not reuse empty drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place.

Do not pour or spray toward an open flame. This product may be harmful if swallowed. Do not use on humans or animals, domestic or otherwise. Do not spray directly on shelled peanuts.
