DIRECTIONS

Peanuts: For the control of alfalfa caterpillar, bean leaf beetle, green cloverworm, Japanese beetle, leafhoppers, thrips and velveltbean caterpillar, use 20-30 lbs. per acre. Some leaf injury may occur if applications are made when tender foliage is wet.

Cotton: For the control of boll weevil, bollworm, cotton flea hopper, Lygus bug and thrips, use 20-30 lbs. per acre. Apply when insects first appear and repeat at 5 to 7 day intervals as required to maintain control. Sevin may be applied after bolls open. Allow 7 days between last application and grazing treated fields or harvesting crop residue for use as feed or bedding for dairy or meat animals.

CAUTION

HARMFUL IF INHALED OR SWALLOWED. Do not take internally. Avoid prolonged breathing of dust.

Skin contact may be harmful. Avoid unnecessary contact.

Wash hands before eating. Take shower or bath after work.
