the control of the following insects attacking lawns and turfs:
ants, fire ants, harvest ants, leaf-cutting ants, earwigs: Large area apply 10 lbs. per acre. Small area apply 1/4 lb. to each 30 feet square. If possible work into the top of soil.

Chiggers, ticks: Apply to the infested area 10-20 lbs. per acre. Small area apply 1/2 lb. to each 30 feet square.

Asiatic Garden beetle larvae, European chafer larvae, green June beetle larvae, Japanese beetle larvae, white fringed beetle larvae, white grubs, wireworms: For large areas apply 23 lbs. per acre. Small areas 1/2 lb. to each 1000 square feet. If possible work into the top of soil.

Lawn moth and sod webworms: On large areas apply 25 lbs. per acre. Small areas apply 1/2 lb. per 900 square feet.
