RECOMMENDATIONS

COTTON: For the control of Boll Weevil, Cotton Aphid, Cotton Leafworm, Spider Mites and Thrips apply 20 pounds per acre. Consult your State Agricultural Experiment Station or State Agricultural Extension Service for time and number of applications.

TRUCK CROPS. As indicated, apply at five to seven day intervals as necessary for control. Do not apply to plants unless they are dry as injury may occur. Dust at the rate of 35 lbs. per acre, equal to 1-3/4 oz. per 50 feet of row.

BEANS—For the control of Mexican bean beetles, leafhoppers, spider mites, Japanese beetles, aphids, cucumber beetles. Do not harvest within one day of application: Apply 30 to 35 lbs: per acre.

COLE CROPS & LEAFY VEGETABLES-Broccoli, Brussels sprouts, cabbage, colliards, kale, mustard greens, parsley, turnips. For the control of aphids. Do not harvest within 7 days of application. Apply 30 to 35 pounds per acre.

CUCURBITS—Cucumber, mellons. Do not apply within one day of harvest. For the control of aphids, pickle worms, leafhoppers, apply 32 to 35 lbs per acre.

LETTUCE AND SPINACH-For the control of aphids: Do not apply to head lettuce within 7 days of harvest or leaf lettuce within 14 days of harvest.

PEAS—For the control of pea aphids, pea weevils: Do not apply within 7 days of harvest. Apply 30 to35 lbs per acre.

POTATOES—For the control of aphids, leafhoppers, mealy bugs. Apply 30 to 35 lbs per acre. TOMATOES—For the control of aphids. Do not apply within one day of harvest. Apply 35 pounds per acre.

POULTRY HOUSES- For the control of Northern Fowl Mites, Chicken Red Mite and Poultry Lice, apply 3/4 pound per 50 to 60 square feet of litter, floor space, nests, roosts and adjacent areas. Repeat as necessary.

CATTLE—For the control of lice on beef cattle make a thorough application to the animals. Repeat application within 10 days and thereafter as needed. Avoid contamination of feed, food containers andwatering troughs. Do not treat lactating dairy animals. Do not apply later than 5 hours before milking or during milking. Do not treat calves under one month of age. SWINE-For the control of lice on swine, make a thorough application of the animals. Pens should be dusted: Repeat application in 10 days and thereafter as needed: Do not treat animals under I month of age.

RECOMMENDATIONS

COTTON: For the control of Boll Weevil, Cotton Aphid, Cotton Leafworm, Spider Mites and Thrips apply 20 pounds per acre. Consult your State Agricultural Experiment Station or State Agricultural Extension Service for time and number of applications.

TRUCK CROPS. As indicated, apply at five to seven day intervals as necessary for control. Do not apply to plants unless they are dry as injury may occur. Dust at the rate of 35 lbs. per acre, equal to 1-3/4 oz. per 56 feet of row.

BEANS—For the control of Mexican bean beetles, leafhoppers, spider mites. Japanese beetles, aphids, cucumber beetles. Do not harvest within one day of application: Apply 30 to 35 lbs: per acre.

COLE CROPS & LEAFY VEGETABLES—Broccoli, Brussels sprouts, cabbage, colliards, kale, mustard greens, parsicy, turnips. For the control of aphids. Do not harvest within 7 days of application. Apply 30 to 35 pounds per acre.

CUCURBITS—Cucumber, mellons. Do not apply within one day of harvest. For the control of aphids, pickle worms, leafhoppers, apply 32 to 35 lbs per acre.

LETTUCE AND SPINACH—For the control of aphids: Do not apply to head lettuce within 7 days of harvest or leaf lettuce within 14 days of harvest.
