DIRECTIONS

PEAS, BEANS, CABBAGE, COLLARDS, LETTUCE, MUSTARD, TURNIPS: For aphid control, apply 12.5 lbs. Master Brand 2% Ethyl Parathion per acre. Inspect vegetables frequently for insects and insect damage so that the insecticides can be applied before damage becomes severe. Applications of insecticides should be made every two weeks or oftener if needed. It is usually necessary to apply insecticides more often during periods of rainy weather and heavy infestations. Be sure to dust thoroughly at lay-by time.
