DIRECTIONS

For the control of the following insects ATTACKING PECANS:

Spider mites, aphids: 2-3 lbs. of this material per 100 gallons of water. Full coverage of the infested tree is essential, repeat as needed.

Pecan nut casebearer, after first generation eggs begin to hatch: 3 lbs. of this material per 100 gallons of water. Full coverage of the infested tree is essential. Repeat as needed.

Pecan phylloxera, early Spring, after unfolding pecan buds develop from 1-3 inches of green growth: 3 lbs. per 100 gallons of water. Full coverage of the infested tree is essential.

Pecan bud moth: 3 lbs. per 100 gallons of water, apply 4-5 times, 2-3 weeks apart when insects appear. Full coverage of the infested tree is essential.

FOR CONTROL OF LICE, TICKS AND HORN FLIES ON BEEF CATTLE AND NON-LACTATING DAIRY CATTLE:

Beef and non-milking cattle, for the control of lice, ticks and horn fly, use:  $3/4$  -  $1\ 1/4$  lbs. per 5 gallons of water. Apply complete coverage spray. Repeat application at 2 week intervals if needed.

Do not treat calves under one month of age.

repeat use: 3 lbs. per 100 gallons of water; apply 4-5 times, 2-3 weeks apart when insects appear. Full coverage of the infested tree is essential.

**FOR CONTROL OF LICE, TICKS AND HORN FLIES ON BEEF CATTLE AND NON-LACTATING DAIRY CATTLE:**

Beef and non-milking cattle, for the control of lice, ticks and horn fly, use:  $3/4$  -  $1\ 1/4$  lbs. per 5 gallons of water. Apply complete coverage spray. Repeat application at 2 week intervals if needed.

Do not treat calves under one month of age.

Do not apply to lactating dairy animals. Do not spray non-lactating dairy animals within 2 weeks of freshening.

When applying sprays and dusts avoid contamination of feed, food containers and watering troughs.
