This material is a special formulation of Captan and Maneb which, when used at the correct application rates, protects Peanut seed against seed-borne or soil-borne diseases such as damping off, root rot, seed decay, seedling blight and fungus.

RECOMMENDATIONS

Apply at the rate of 2 to 4 ounces per 100 lbs. of Peanut seed by mixing the Captan-Maneb with the seed in the planter box, drill box or the hopper of the dust applicator. **DO NOT MIX WITH HANDS**

IMPORTANT! Bags containing treated seed should be labelled as Follows: TREATED SEED — DO NOT USE FOR FEED, FOOD OR OIL PURPOSES.
