### **DIRECTIONS FOR USE**

This spray may be applied with a sprayer or with a paint brush so as to wet surfaces over which insects crawl or crevices in which they live.

ROACHES—Remove all dishes, food, utensils, pots and pans, etc. from the area to be sprayed. Make spot applications to infested roach haunts directing the spray into cracks and crevices. Inspect and treat the undersides of shelves, drawers, baseboards, pipeholes, cracks in walls, seams of door jambs, and under sinks. Use a flashlight to inspect dark areas under refrigerators, behind stoves, and behind cabinets. In bathrooms treat under sinks, behind the tub, and under baseboards. In other rooms remove drawers from dressers and treat the dresser frames. In the basement inspect and treat infested areas around washing machines, sinks, and pipe runs.

Allow surfaces to dry completely before replacing dishes, foodstuffs, etc.
