

DIRECTIONS

This product should be applied as a coarse (large drop) spray in spot treatment of localized surface areas only.

Roaches: Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts—behind sinks, into cracks and crevices, the underside of all drawers, baseboards, pipeholes in walls, and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bathrooms, cracks and crevices in closets, dresser drawers and frames.

Ants, Spiders, Silverfish, Crickets, and Earwigs: Spray areas where these pests are found or may hide including dark corners of rooms and closets, cracks, and crevices along baseboards and door sills and frames behind and beneath sinks, stoves, refrigerators, and cabinets, and around garage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests, and points of entry. Repeat treatment as required.

Flies and Mosquitoes: Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.
