STATEMENT OF PRACTICAL TREATMENT

IF ON SKIN: In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.

IF IN EYES: Flush eyes with plenty of water. See a physician if irritation persists.

Note to Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection only is antidotal.

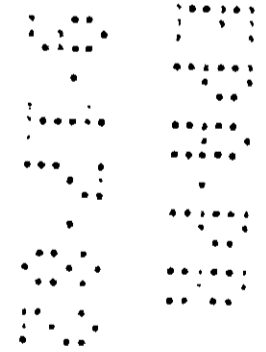

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**SHAKE WELL BEFORE USING**

Remove child-proof cap and insert trigger sprayer before use.

**DO NOT SPRAY PETS DIRECTLY WITH THIS PRODUCT.**

Use **Double Duty Indoor-Outdoor Bug Killer** as a spot treatment to help control fleas and ticks. Apply as a fine spray mist to localized areas where pests may occur. Spray surfaces thoroughly but only until wet. Re-treat as needed. Spot test for color fastness before use.

**Fleas and Brown Dog Ticks Indoors:** To control these pests, apply thoroughly as a fine mist to infested areas such as pet beds, resting quarters, in cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where pests may be present. Old pet bedding should be removed and replaced with fresh bedding after treatment.

**Fleas and Brown Dog Ticks Outdoors:** For treatment of localized infestations of these pests outdoors, thoroughly spray infested areas. Repeat application as infestation warrants and as reinfestation occurs.

Apply only as a fine mist surface spray. Do not replace dishes and food in the treated areas until spray is dry. Do not eat any food or crops sprayed with this product.

**STORAGE AND DISPOSAL**

Do not reuse empty container. Wrap container and put in trash collection.
