**CAUTION:**

This collar is intended for use as an insecticide and fatty acid generator and is not to be taken internally by man or animal. Not intended for use on humans. The insecticide in this collar is a cholinesterase inhibitor. Do not allow children to handle or play with this collar.

**Note to Physicians:** This product contains a cholinesterase inhibitor. Atropine sulfate and 2-PAM are antidotal only if signs of cholinesterase inhibition are present.

Do not use other pesticides on cat while collar is worn. Some cats and humans may be sensitive to this collar. Remove at first sign of irritation or adverse reaction. Do not use on sick or convalescing animals. Do not use on Persian cats.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this collar in a manner inconsistent with its labeling.

Place DOUBLE DUTY PLUS Collar around cat's neck, adjust for proper fit and buckle in place. Cut off and dispose of the excess length. The collar must be worn loosely so that two fingers can be placed between collar and cat's neck. If collar is worn too tightly, it may produce neck irritation. Activity against fleas starts within 24 hours, reaches maximum effectiveness in 3-4 days and continues as long as the collar is worn (up to 150 days). Ticks are relatively harder to kill and die more slowly. Activity against ticks will occur within a few days and will continue killing and controlling ticks for up to 120 days. Fleas and ticks present in the animal's environment that may reappear on the cat will be killed and controlled by the action of the collar. Replace collar when effectiveness diminishes. Collar is not affected by normal wetting such as rainfalls; however, it is suggested collar be removed before bath.

This Double Duty™ PLUS collar contains NutriSorb™ which releases unsaturated fatty acids necessary for healthy skin and hair. Unsaturated fatty acids are rapidly absorbed to help maintain a lustrous, manageable coat.

**DISPOSAL:** Do not reuse empty pouch or box. Wrap pouch or box and put in trash collection. When discarding used collar, wrap in newspaper and place in trash collection.
