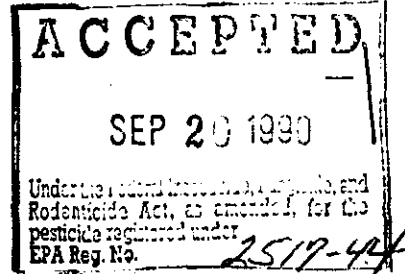

**CAUTION:** Do not open inner envelope until ready to use. Collar is intended for use only as an insecticide generator and is not to be taken internally by man or animals. Even with the Bansect<sup>®</sup> Collar, some cats may be sensitive and may develop neck irritation and loss of hair under the Collar if it is worn too tightly. When Collar is first worn, observe neck area for irritation every few days. Remove Collar if there is evidence of irritation and permit area to heal. Do not use on sick or convalescing cats. Do not use any other pesticide while Collar is worn. Do not use on kittens under 3 months of age.

#### IMPORTANT CONSUMER INFORMATION

##### DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

THIS COLLAR KILLS ALL TYPES OF FLEAS common to cats, and should be worn continuously to help reduce flea infestations. Buckle Collar securely but not tightly around cat's neck. COLLAR SHOULD BE WORN LOOSELY. Cut off and dispose of excess length in trash. Collar will start killing fleas on cat immediately. New fleas temporarily appearing will be killed during four months Collar is worn. When bathing cat, remove Collar, until cat is dry. Replace when effectiveness diminishes. THIS COLLAR KILLS TICKS more slowly, but ticks will usually be dead in one to five days. Although ticks are only an occasional problem on cats, Collar will continue to aid in tick control for thirty days. Dead ticks occasionally remaining in cat's coat are easily detached. For best results, remove hard-to-kill ticks inside ears when Collar is put on.

##### STORAGE & DISPOSAL:


**STORAGE:** Store only in original container, in a cool dry place inaccessible to children and pets.

**DISPOSAL:** Discard in the trash the empty pouch, the expired Collar and any trimmed excess Collar.
