No. 2517-63<br/>Your Submissions Dated October 28, 2008 and March 12, 2009

Dear Ms. Kane:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable with the following label revision provision(s):

#### Marketing Statements section comment(s):

- 1. To facilitate inclusion of language from the RED for permethrin, revise the marketing statement "puppies" to read "puppies (over 12 weeks of age)."
- 2. In all instances throughout this label, delete "With Oatmeal" and "**SHAKE WELL:** Contains Colloidal Oatmeal." In addition, delete these terms in any alternate brand names that were submitted as Notifications, since you cannot market a product which is based on an alternate formulation, as per 40 CFR §152.43. Finally, the inert ingredient listing listed in the Ingredient Statement is inaccurate since colloidal oatmeal is listed in the alternate and not in the basic formulation.

Precautionary Statements section, Hazards to Humans and Domestic Animals subsection comment(s):

3. Replace the existing 7<sup>th</sup> and 8<sup>th</sup> sentences in this subsection with: "Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Apply this product only as specified on this label. Except when applying directly to pets, do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Do not treat (use on) animals less than twelve (12) weeks of age."

#### First Aid Statement section, HOT LINE NUMBER subsection comment(s):

4. Replace this section with: "Have the product container or label with you when calling a poison control center or veterinarian. For additional information on this product (including health concerns, medical emergencies or pesticide incidents), you may call 1-800-781-4738." It is important to note that the "1-800-781-4738" number listed must be available twenty-four (24) hours per day, seven (7) days per week for answering and responding to any medical emergencies or health concerns.

Sergeant's Pet Care Products, Inc. should note that a notice of availability of EPA's RED for products containing piperonyl butoxide was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386). As a result, additional data and/or labeling changes may be required for products containing piperonyl butoxide.

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.
