- 1. The statement "No Hydrocarbon Or Fluorocarbon Propellants" must be deleted from the label. Until the Agency develops a policy for allowing such statements to appear on product labels, the above statement is unacceptable.
- 2. Under the Important Consumer Information paragraph delete the sentence "This product is contained in the revolutionary new Atmos Non-Gas Aerosol delivery system which contains no hydrocarbon or fluorocarbon propellants."
- 3. The following statements on the front panel of your label must be deleted.
 - a. Revolutionary Non-Gas Aerosol Delivery System
 - b. [Atmos Non-Gas Aerosol]

The above statements must be deleted from the label at this time until the Agency develops a policy of allowing statements such as the above to appear on product labeling.

Submit five copies of final printed labeling incorporating the above statement before you release this product for shipment bearing this label.
