Dear William L. Washburn:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments below. Three (3) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Add "Permethrin" to the Active Ingredient statement.
2. Remove "Harmful if swallowed. Avoid breathing vapors." from Precautionary Statement and ADD, "Causes moderate eye irritation. Avoid contact with eyes or clothing. Harmful if absorbed through skin. Wash thoroughly with soap and water after handling.
3. The acute oral and inhalation toxicity are classified as category IV, no First Aid statements are required. However, if you choose to retain the First Aid labeling that is acceptable.

IMPORTANT CONSUMER INFORMATION

PURPOSE: Sergeant's Residual Flea & Tick Spray is specially formulated to kill fleas on your pet for up to 14 days, and will kill ticks for 4 days (DOGS), 9 days (CATS). (The product may be sprayed from any angle for ease of application - even upside down! It is also quieter than normal aerosol sprays and, therefore, less frightening to your pet.)

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL

Remove cap; from a distance of approximately 8-12 inches spray pet against the lay of the coat, fluffing long hair so mist reaches pet's skin (include the legs and underbody but avoid the face, eyes, and genitalia). The spray should wet ticks thoroughly. [For Cats] Apply at a rate of 1 second per pound of body weight. [For Dogs] Apply at a rate of 2 seconds per pound of body weight for thin or shot-haired dogs and up to 8 seconds per pound of body weight for heavy or long-haired dogs.
Reapply every week.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Avoid breathing vapors. Do not spray pet's face, eyes, or genitalia. Do not use on nursing kittens or animals under 12 weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant, medicated, or nursing animals. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

ENVIRONMENTAL HAZARDS

This product is toxic to fish and other aquatic invertebrates. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.
