Dear William L. Washburn:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide. Fungicide, and Rodenticide Act, as amended, is acceptable subject to comments below. Three (3) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. Revise statement "Kills the Ticks That Carry Lyme Disease" to "Kills the Ticks That May Carry Lyme Disease".
- 2. Remove "Harmful if swallowed. Avoid breathing vapors." form Precautionary Statement and ADD, "Causes moderate eye irritation. Avoid contact with eyes or clothing. Harmful if absorbed through skin. Wash thoroughly with soap and water after handling.
- 3. The acute oral and inhalation toxicity are classified as category IV, no First Aid statements are required. However, if the you choose to retain the First Aid labeling that is acceptable.

DIRECTIONS FOR USE

SHAKE WELL. Remove cap; from a distance of approximately 8-12 inches and starting at the tail spray pet against the lay of the coat, moving the dispenser rapidly, fluffing long hair so spray penetrates to the pet's skin (include the legs and underbody but avoid the face, eyes, and genitalia). The spray should wet ticks thoroughly. For cats apply at a rate of ! second per pound of body weight. For dogs apply at a rate of 2 seconds per pound of body weight for heavy or long-haired dogs. Reapply every week.
