DIRECTIONS FOR USE

SHAKE WELL. Remove cap; from a distance of approximately 8-12 inches and starting at the tail, spray pet against the lay of the coat, moving the dispenser rapidly, fluffing long hair so spray penetrates to the pet's skin (include the legs and underbody but avoid the face, eyes and genitalia). The spray should wet ticks thoroughly. For cats, apply at a rate of 1 second per pound of body weight. For dogs, apply at a rate of 2 seconds per pound of body weight for heavy or long-haired dogs. Reapply every week.
