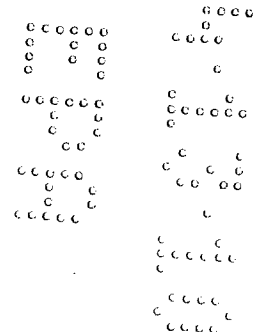

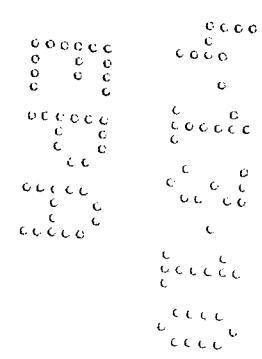

**PURPOSE:** Sergeant's flea & Tick spray is specially formulated to kill fleas on your pet for up to 14 days, and will kill ticks for (4 days on dogs) (9 days on cats). [The product may be sprayed from any angle for ease of application – even upside down! It is also quieter than normal aerosol sprays and, therefore, less frightening to your pet].\*\*

### DIRECTION FOR USE

**It is a violation of Federal law to use this product in a manner that is inconsistent with its labeling. SHAKE WELL.** Remove cap; from a distance of approximately 8-12 inches and starting at the tail spray pet against the lay of the coat, moving the dispenser rapidly, fluffing long hair so spray penetrates to the pet's skin (include the legs and underbody but avoid the face, eyes, and genitalia). The spray should wet ticks thoroughly. For cats apply at a rate of 1 second per pound of body weight. For Dogs apply at a rate of 2 seconds per pound of body weight for heavy or long-haired dogs.
