The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin Interim Decision and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.



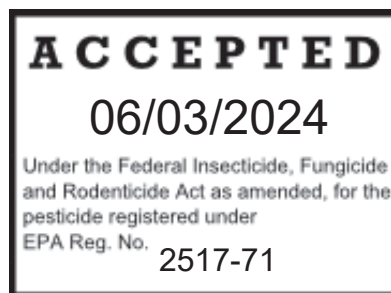

SHAKE WELL. Remove cap; from a distance of approximately 8-12 inches and starting at the tail spray pet against the lay of the coat, moving the dispenser rapidly, fluffing long hair so spray penetrates to the pet's skin (include the legs and underbody but avoid the face, eyes, and genitalia). The spray should wet ticks thoroughly. Apply at a rate of 2 seconds per pound of body weight for heavy or long-haired dogs. Reapply every week. Application of product on pets must only be done indoors.
