It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**Shake Container Well Before Using.**

Apply 16 ounces of powder to treat 1 to 2 rooms (200 - 400 square feet). When using this product at the lower rate of 16 ounces to treat 400 square feet, allow the powder to remain in place for 24 hours removing with a vacuum cleaner. Apply powder at the higher rate (16 ounces to 200 square feet) to areas of flooring or furniture on which pets spend most of their time.

**Apply to dry surfaces only. Do not wet powder.**

**Carpets:** Shake [Apply] powder evenly across surface. Brush lightly with broom to force powder deep into carpet where fleas and their larvae exist. Wait at least 60 minutes before (lightly) vacuuming to remove visible surface powder. For maximum efficacy [effectiveness], delay vacuuming for up to 24 hours.

**Upholstery [& Furnishings]:** Remove loose cushions. Sprinkle along creases and into corners. Use a brush to lightly work powder into folds and creases. Vacuum to remove visible powder on surfaces. Do not use on exposed fabric without first testing on a hidden surface for effects on color (staining) or texture. If powder adheres to a spot, brush out and remove with a vacuum immediately.

When emptying vacuum bag after use, wrap contents or disposable bag in several layers of newspaper and discard in trash.

Treat pets with a registered flea and tick control product prior to re-entry.
