On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product when the Agency requires all registrants of similar products to submit data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.

2. Make the labeling changes listed below before you release the product for shipment:

a. Add the phrase "EPA Registration No.2517-82 ."

b. Delete the following claims or phrases, "Sterilized (All New) Fleas and Kills their eggs for 30 days"; "Kills the ticks that may cause lyme disease"; "Kills flea eggs for 30 days"; xxx for 30 days (on back panel). Only the efficacy data cited under MRID 44556601 supports a kill and control claim for fleas and ticks to 10 days. MRID 42614501 pertained to a product with different active ingredients; MRID numbers 45086801 and 44948301 pertained to a manufacturing use product and a product applied as a surface treatment only, not for use on pets. You may want to check with your supplier in this regard. Please submit a corrected data matrix for efficacy.

c. You agree to submit the result's of product storage stability (830.6317) and corrosion characteristics (830.6320) when complete.

d. The supplier's name in Column 11 of the Confidential Statement of Formula (CSF) must be in the same as the manufacturer of a non-cleared inert ingredient in the Confidential Appendix A. (see enclosed review).

e. Based on a Toxicity Category III classified under First Aid add "If on skin or clothing. Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice."

f. Replace "To maintain maximum effectiveness against both fleas and ticks, repeat (or reapply) ever week," to "Do not apply more frequently than at 30 day interval.". This is based on the companion animal safety study cited in support of this product."

g. Replace "Do not use on dogs under 12 weeks.". with "Only for use on adult dogs or dogs older than 6 months.". This is based on the companion animal safety study cited in support of this product.

h. Since this product undiluted could irritate skin under Directions for Use add "Wear waterproof gloves when applying product."
