The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cyphenothrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Do not apply this product to foals less than three (3) months of age. Consult a veterinarian before using this product on debilitated, aged, pregnant, or nursing horses. Do not apply this product to animals other than horses. Sensitivities may occur after using ANY pesticide product on horses. If signs of sensitivity occur, bathe your horse with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Application of product on horses must only be done indoors.

## HOW TO APPLY:

This product is packaged in ready to use applicator tubes and does not require dilution. Hold the applicator tube with the top end pointing up and away from face and body. Snap off or remove the applicator tube tip with scissors. Invert the applicator tube and squeeze to apply product onto the horse.

**Two (4.5 mL) tubes per application.** [Each application is two 4.5 mL tubes per horse.]

**Tube 1:** Poll, hind quarters and one side of withers.

**Tube 2:** Front legs, Hind legs, and other side of wither.

1. Apply 2 mL on the poll, taking care to keep away from the eyes and mucous membranes.
2. Streak 0.5 mL on each side of withers (1 mL total).
3. Streak 1 mL on each side of hindquarters (2 mL total).
4. Streak 1 mL on each front leg below the knee (2 mL total).
5. Streak 1 mL on each hind leg below each hock on the gaskin muscle (2 mL total).

Reapply every 3 weeks (21 Days) only as needed to maintain pest control.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in a cool, dry area, preferably locked and away from children and pets. Do not allow product to freeze by storing at temperatures below 32°F (0°C). Do not store in a manner that will adversely affect the applicator tube(s) or outer packaging.

**Pesticide Disposal:** Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Do not pour or dispose down the drain or sewer. Call your local solid waste agency for local disposal options.

**Container Disposal:** Offer for recycling or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke. You may also contact your local solid waste agency (or 1-800-CLEANUP) for disposal instructions.
