The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the referenced product in connection with the PERMETHRIN **RED**, and have concluded that your submission is acceptable with the following label revision provision(s):

General Comment(s):

In the Directions for Use section change "horsed" to "horses". In the bullets panel change "Hourses and Houses" to "Horses".

First Aid section comment(s):

You may delete the "IF SWALLOWED and IF ON SKIN OR CLOTHING" sections. The toxicity category for Acute Oral, Acute Dermal, Acute Inhalation and Primary Dermal are Category IV and it is a non-sensitizer.

Environmental Hazards section comment(s):

After "Do not contaminate water when disposing of equipment washwaters, or rinsate." add "See Directions for use for additional precautions and requirements.".

Hazards to Humans and Domestic Animals section comment(s):

Replace this section with Causes moderate eye irritation. Avoid contact with, eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove contaminated clothing and wash clothing before reuse.

Should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency.
