1. Streak 0.04 fl. oz (1 cc) on top of the croup.
2. Streak 0.04 fl. oz (1 cc) on the forehead under the forelock, taking care to avoid the eyes and mucous membranes.
3. Spot 0.04 fl. oz (1 cc) over the dorsum of the carpus (front of the knee) of each front leg [0.07fl. oz.(2 cc) total]
4. Spot 0.04 fl. oz (1 cc) the planter surface of the tarsus (behind the hock) of each hind leg [0.07 fl. oz. (2 cc)total]

Place empty applicator in the trash.
Do not reapply for 14 days.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in original container in a cool, dry place inaccessible to children and pets. Protect from freezing.

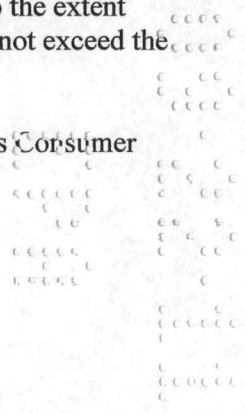
