The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Hold tube in upright position, pointing away from user's face and body. Break off tip or cut with scissors. Using the cc guide marks on the tube apply MQHP-1 as follows:

- 1. Streak 0.04 fl. oz (1 cc) on top of the croup.
- 2. Streak 0.04 fl. oz (1 cc) on the forehead under the forelock, taking care to avoid the eyes and mucous membrane.
- 3. Spot 0.04 fl. oz (1 cc) over the dorsum of the carpus (front of the knee) of each front leg [0.07fl. oz (2 cc) total]
- 4. Spot 0.04 fl. oz (1 cc) the planter surface of the tarsus (behind the hock) of each hind leg [0.07fl. oz (2 cc) total]

Place empty applicator in the trash.

Do not reapply for 14 days.
