Hold the container upright. Spray at a distance of 8 to 12 inches. Spray over entire haircoat making sure the coat is thoroughly wetted to the skin. As you spray, fluff the hair so the spray will penetrate to the skin. Do not spray into the eyes, face or genitalia. Make sure spray wets ticks thoroughly. Spray against the lay of the hair, roughing the hair on long-haired [dogs] [or] [cats]. Weight of [dog] [or] [cat], length of hair and density of coat will determine amount of spray to be applied to wet the skin [average dose approximately 7.5 g/kg for dogs] [and] [5 g/kg for cats].
