- Consult a veterinarian before applying this product on medicated, debilitated, aged, pregnant or nursing animals.

Weight of [dog] [or] [cat], length of hair and density of coat will determine amount of spray to be applied to wet the skin [average dose approximately 7.5 g/kg for dogs] [and] [5 g/kg for cats].
