- Do not apply to pets less than 12 weeks old.
- Consult a veterinarian before applying this product on medicated, debilitated, aged, pregnant or nursing animals.
- Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.
- Remove birds and cover fish aquariums before spraying.

Hold the container upright. Spray at a distance of 8 to 12 inches. Spray over entire haircoat making sure the coat is thoroughly wetted to the skin. As you spray, fluff the hair so the spray will penetrate to the skin. Make sure spray wets ticks thoroughly. Spray against the lay of the hair, roughing the hair on long-haired [dogs] [or] [cats]. Weight of [dog] [or] [cat], length of hair and density of coat will determine amount of spray to be applied to wet the skin [average dose approximately 7.5 g/kg for dogs] [and] [5 g/kg for cats]. [This 16 oz. bottle should be sufficient for [three applications to an average 30-35 lbs. of dog] [or] [20 applications to a 10 lb. cat]]. OR [This 8 oz. bottle should be sufficient for [two applications to an average 20-25 lbs. of dog] [or] [10 applications to a 10 lb. cat]]. Do not spray into the eyes, face or genitalia. When applied at the label dose rate, the [dog] [or] [cat] should not be retreated more frequently than once every 14 days. Lighter applications will reduce period of effectiveness, may result in earlier reinfestation and may require more frequent retreatment.
