## DIRECTIONS FOR USE

**It is a violation of Federal law to use this product in a manner inconsistent with its labeling.**

### [SHAKE WELL BEFORE USE]

FOR USE ON [CATS] [AND] [KITTENS (over 12 weeks of age)], [DOGS] [AND] [PUPPIES (over 12 weeks of age)] TO KILL FLEAS AND TICKS:

Hold the container upright. Spray at a distance of 8 to 12 inches. Spray over entire haircoat making sure the coat is thoroughly wetted to the skin. As you spray, fluff the hair so the spray will penetrate to the skin. Make sure spray wets ticks thoroughly. Spray against the lay of the hair, roughing the hair on long-haired [dogs] [or] [cats]. Weight of [dog] [or] [cat], length of hair and density of coat will determine amount of spray to be applied to wet the skin [average dose approximately 7.5 g/kg for dogs] [and] [5 g/kg for cats]. [This 16 oz. bottle should be sufficient for [three applications to an average 30-35 lbs. of dog] [or] [20 applications to a 10 lb. cat]]. **OR** [This 8 oz. bottle should be sufficient for [two applications to an average 20-25 lbs. of dog] [or] [10 applications to a 10 lb. cat]].
