

The dual synergized pyrethrins provide immediate killing of fleas and ticks on pets Pyriproxyfen , in this special formulation, is absorbed onto, and sticks tightly to hair and skin, even after complete rinsing This insect growth regulator (a synthetic flea hormone) sterilizes all fleas that jump onto the pet (even new fleas before they start laying eggs) and therefore kills all flea eggs This action persists for 1 month and breaks the flea's life cycle by preventing the development of new fleas in the pet's environment and the build-up of reinfestation pressure
