

[(3.0 ml applicator tubes) Apply approximately half of the tube (1.5 ml) of this product as a spot grosting to the dog's back between the shoulder blades and apply the rest of the tube's contents (1.5 ml) as a spot or stripe to the dog's back directly in front of the base of the tail.]


