Additionally, your company is required to adhere to the spot-on label mitigation, and to submit quarterly enhanced incident reports and quarterly sales information for the above-referenced registrations.

The Agency has found Sergeant's Pet Care Products, LLC to be in compliance with the terms and conditions for the subject products. The Agency is therefore granting the requests to extend the two-year time-limited registration restrictions. As such, the following change is being made to the terms and conditions of the products listed above.

- **The two-year time-limited registration restriction has been extended. The new expiration date for the registrations listed above is now September 11, 2025.**
