

(Sergeants, 2625 South 158th Plaza, Omaha, NE 68130-1770, EPA Company Number 2517) is submitting a notification pursuant to PR Notice 98-10 to add Alternate Brand Names and make other minor notification language revisions to the EPA registered product Sergeant's Fipronil + Cyphenothrin Squeeze-on for Dogs (EPA Reg. No 2517-140). Please find enclosed the following documentation in support of this notification:

- (2) Product label (2 clean copies and 1 copy with changes highlighted).

Sergeant's is adding three Alternate Brand Names to the above named product. Minor typographical changes and other minor revisions are also noted. These minor label changes are being made via notification because they do not affect the dosage, concentration, frequency or method of application or increase the amount of exposure. All changes have been marked using track changes on the first revised label included in this package. We have not submitted a new confidential statement of formula (CSF) because no changes have been made to the CSF on file with EPA.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
