The above registrations contain conditions calling for the registration to expire after two years from the date in the registration notices dated January 13, 2011, March 23, 2011 and March 22, 2011, respectively. The terms of these registrations have been previously updated to extend the expiration dates to December 10, 2019. But for limited Agency resources, your request would have been granted prior to the expiration date. Additionally, your company is required to adhere to the spot-on label mitigation, and to submit quarterly enhanced incident reports and quarterly sales information for the above-referenced registrations.

The Agency has found Sergeant's Pet Care Products, LLC to be in compliance with the terms and conditions for the subject products. You confirmed via email (dated 04/10/2024) that Sergeant's has yet to manufacture and release for shipment these registered products. The Agency is therefore granting the requests to extend the two-year time-limited registration for 2517-140, 2517-141 and 2517-143. As such, the following change is being made to the terms and conditions for the products listed above:

- **The two-year time-limited registration restriction has been extended. The new expiration date for the three registrations listed above is December 10, 2025.**
