You must submit and/or cite all data required for registration of your product under FIFRA §3(c)(5) when the Agency requires all registrants of similar products to submit such data, and submit acceptable responses required for reregistration of your product under FIFRA §4. 3. In the event that the Agency finds that the submitted waiver request is unacceptable for this product, you must provide to the Agency within 30 days of receiving notice, the proposed schedule in which a new Companion Animal Safety study will be conducted and submitted for this product. 4. As a condition of registration for this product, within one year from the date of this registration, you must submit the results of Storage Stability and Corrosion Characteristics studies, corresponding to OCSPP Guidelines 830.6317 and 830.6320, respectively, including interim 			

reports made at 0, 3, 6, 9, and 12 month intervals.

All labeling comments below are in reference to the proposed master label, dated October 25, 2010.

5. Per the Agency's product efficacy review dated June 8, 2011, make the revisions to the following labeling claims:

Delete the following claims in quotes:

- A. Page 1 under list of claims: "[Year long protection]"
- B. Page 1 under list of claims: "[Deodorizes]"
- C. Page 1 under list of claims: "[Deodorizing]"
- D. Page 2 under list of claims: "[new-improved]" - this claim is only permitted for 6 months after the date of this registration.
- E. Page 2 under list of claims: ["last an additional month!"]
- F. Page 3 under Product Information: "To truly eliminate a flea infestation the [Product Name] kills those pre-adult forms, to prevent reinfestation."

Revise the following claims:

- A. Throughout the label, all references to "cats" or "kittens," including in alternate brand names, must include the statement "over 12 weeks of age" since there is no safety data for cats younger than this age.
- B. Throughout the label, all references to "ticks" must say "ticks on dogs" since the efficacy data for tick data for cats was not supported.
- C. Throughout the label, all statements referring to duration of efficacy on adult fleas or ticks on dogs must include "for up to 6 months" (no brackets allowed).
- D. "Kills fleas and ticks for six [6] months and controls flea reinfestation for up to 13 months]" to read "Kills fleas and ticks on dogs for up to six [6] months and controls flea reinfestation for up to 6 months]."
- E. Throughout the label, all references to efficacy duration must accompany the claim (no brackets). The only duration supported by data is "for up to 6 months" - all other durations "[7][8][9][10][11][12][13] months" must be *deleted*:
 - "Long Lasting protection for up to [6][7][8][9][10][11][12][13] months!"
 - "Up to [6][7][8][9][10][11][12][13] month protection"
 - "[Continuous] [6][7][8][9][10][11][12][13]-month protection]"
 - "Controls flea reinfestation for up to 6 13 months"
 - "Controls flea reinfestation for up to [6][7][8][9][10][11][12][13] months"
 - "This collar kills fleas and tick and provides up to [13][12][11][10][9][8][7] [6] months of protection from reinfestation for your [dog] [and] [cat]."
 - "This collar protects your pet against reinfestation for up to [6][7][8][9][10][11][12][13] months."
- F. "[Fast Acting]" to read "Starts killing fleas and ticks fast within 6 hours."
- G. "[Quick Kill]" to read "Starts killing fleas and ticks quickly within 6 hours."
- H. Delete "fragrance" to now read "[Fresh][Powdery][Clean] Scent [_____ fragrance]."
- I. "Do not use on pets under 12 weeks of age" to read "**RESTRICTION**: Do not use on pets under 12 weeks of age" to make the statement more prominent.

6. On page 2, delete the optional statement "{Ingredient Statement may be on front or back label}"

because the Ingredients Statement must be placed on the front panel of the label, and no rationale was provided for the Agency's consideration to allow an alternate location.

- 7. On page 2 in the Ingredients Statement, delete the brackets around "Total 100.0%" because this is required.
- 8. On page 3, per the Acute Toxicity Review, revise the Hazards to Humans and Domestic Animals statement to read as follows:

"Harmful if swallowed. Causes moderate eye irritation. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Avoid contact with eyes or clothing."

- 9. On page 3 under Product Information, revise the statement by deleting the struck-out text as follows, because part of the statement is unclear, or appears to be misleading, based on the expected exposure from the pet collar:

"Collar is a ~~double-layer~~ sustained-release system [containing four active agents] ~~combining the insecticidal actions of vapors and powders, working in [two] [three] [four] ways to provide fast acting [quick kill] [acts fast in 6 hours] [stats to kill in 6 hours] and head-to-tail protection.~~"

- 10. On page 4, revise the First Aid Statement to read as follows:


"If swallowed...
If in eyes..."

- 11. On page 5 in the Warranty Statement, delete the statement "All such risks shall be assumed by the user or buyer," and, delete all internal brackets to include the Warranty Statement in its entirety, if used.
- 12. Revise the EPA Registration Number to read: "EPA Registration No. 2517-144."

One copy of the finished labeling must be submitted prior to releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these terms. A copy of your label stamped "Accepted with Comments" is enclosed for your records.
