

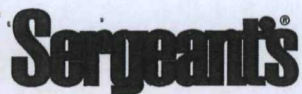

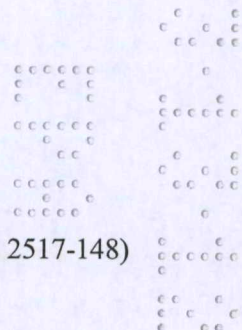

Sergeant's Pet Care Products, Inc. (Sergeants, 10077 South 134th St, Omaha, NE 68138-1710, EPA Company Number 2517) is submitting a notification of revision to the master label for the end-use product Sergeant's Fipronil + Etofenprox Spot-on for Cats (EPA Reg. No. 2517-148), containing the active ingredients fipronil and etofenprox. The following items are enclosed in support of this notification:

- Application for Pesticide Notification (EPA Form 8570-1); and
- Master Label v. 12.1 (2 copies, 1 with changes highlighted).

Sergeant's is submitting this notification to add an optional marketing claim and a few optional graphics to the label with the appropriate text. This minor label change is being made via notification because it does not affect the dosage, concentration, frequency or method of application or increase the amount of exposure. All changes have been highlighted on the first revised label included in this package.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
