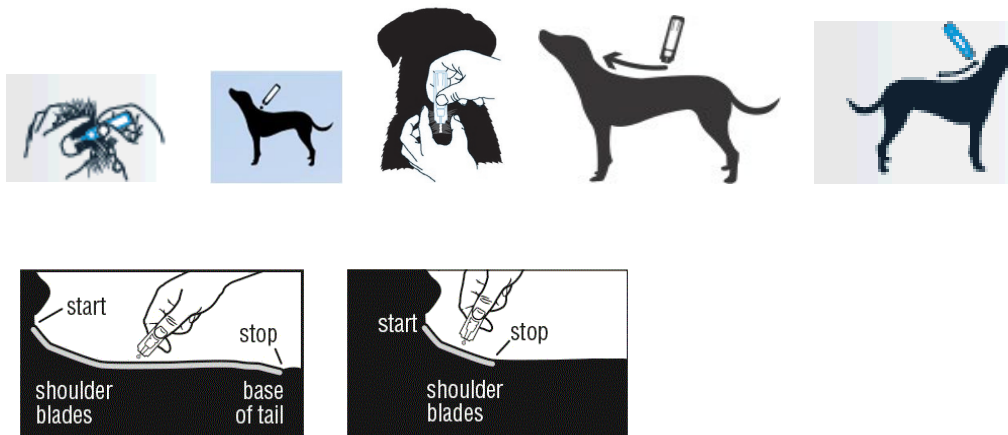

[Flea life cycle diagram] [Flea Life Cycle]

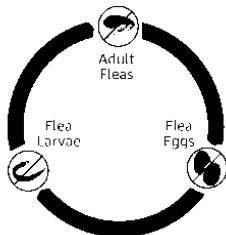
